



## LICENSE AGREEMENT

hereinafter referred to as the “Author”, on the one hand, and Limited Liability Company  
“Mediamusic” represented by General Director Maksim V. Bysko, acts on the basis of the  
Charter, hereinafter referred to as the “Company”, on the other hand, we have concluded this  
agreement on the following:

### 1. Subject of the agreement:

1.1. On a non-repayable basis, the Author grants to the Company a non-exclusive license to use  
of the scientific literary work (article):

WORK TITLE

1.2. The Author transfers to the Company the work’s exclusive right indicated in Article 1270 of  
the Civil Code of the Russian Federation, for the entire period of copyrights and the entire  
territory of the world. The Author guarantees that the conclusion of this agreement will not lead  
to infringement of copyrights or other rights to the intellectual property of third parties. At the  
same time, the Author guarantees that he (she) has not concluded and will not conclude in future  
contracts that contradict this agreement or make it impossible to fulfill it.

1.3. Within 30 days after the conclusion of this agreement, the Author pays to the Company for  
the services of editing, technical support of the work’s materials (html-layout, xml-files  
production, CD production, archiving and including materials in the science-metric databases,  
scientific libraries and into Informregister), as well as for the services of legal support of the  
work’s multimedia materials. The payment is fixed and it amounts to \_\_\_\_\_ rubles  
or \_\_\_\_\_ USD. Payment is made via the bank or online.

1.4. The Company provides the services for reviewing, editing the work’s materials (including  
the editing of multimedia materials), and publishing the work in the Electronic scientific  
magazine *Mediamusic* (ISSN 2226-6143, Certificate of the mass media registration in Russia is  
El number FS77-56958 of February 02, 2014), of which the Company is the founder and  
publisher.

1.5. The Company provides the services of technical support of the work’s materials, as well as  
services of legal support of the work’s multimedia materials.

## **2. Obligations and rights:**

### 2.1. The Author undertakes:

2.1.1. to provide to the Company the materials of the work in accordance with the *Rules for sending, reviewing and publishing materials*, as well as in accordance with the *Specifications* and *Author's duties* published on the website of the Electronic scientific magazine *Mediamusic*.

2.1.2. to provide to the Company the necessary personal data for publishing it in the Electronic scientific magazine *Mediamusic*.

2.1.3. in the process of preparing a work for publication, to promptly make the necessary changes to it, which indicated by the Editorial board of the Electronic scientific magazine *Mediamusic*.

### 2.2. The Author has the rights:

2.2.1. in the process of preparing a work for publication, to make changes in the work not specified by the Editorial board of the Electronic scientific magazine *Mediamusic*, but having coordinated them with the Editorial board.

2.2.2. in the process of preparing a work for publication, to revoke unpublished work, and to compensate to the costs (losses) incurred by the Company.

### 2.3. The Company undertakes:

2.3.1. to review and edit the work's materials (including the editing of multimedia materials), and publish the work in accordance with the *Rules for sending, reviewing and publishing the materials*, as well as in accordance with the *Reviewer's duties*, *Editor's duties* and *Publisher's duties* published on the website of the Electronic scientific magazine *Mediamusic*.

2.3.2. to carry out technical support of the work's materials (html-layout, xml-files production, CD production, archiving and including materials in the science-metric databases, scientific libraries and into Informregister), as well as legal support of the work's multimedia materials.

### 2.4. The Company has the right:

2.4.1. to store and use the Author's personal data on the website of the Electronic scientific magazine *Mediamusic*, in the science-metric databases, scientific libraries, into Informregister, and also in promotional materials.

2.4.2. to develop independently and publish on the website of the Electronic scientific magazine *Mediamusic* the *Rules for sending, reviewing and publishing the materials*, *Specifications*, norms of publication ethics (*Author's duties*, *Reviewer's duties*, *Editor's duties* and *Publisher's duties*), the form of the License Agreement and other documents.

## **3. Responsibility:**

3.1. In case of violation of the terms of this agreement, the parties are liable in accordance with the current legislation of the Russian Federation.

3.2. The Author is responsible for the violation of copyright or other intellectual property rights of third persons in providing for the publication of his (her) scientific literary work.

3.3. The Company is responsible for the quality of the services provided.

#### 4. Final provisions:

4.1. The amendment of the terms of this agreement is formalized in the form of separate contracts or additional documents to this agreement.

4.2. The agreement is made in two exemplars with the same legal force.
